



NO TO CPR!

NOR VIA CORELLI OR IN ANY OTHER PLACE

VIA CORELLI No 28 CAS IS GOING TO CLOSE, AND GUESTS WILL BE LITTLE ALL TRANSFERRED IN SMALL GROUPS TO OTHER CENTERS BECAUSE IN ITS PLACE THE GOVERNMENT DECIDED TO OPEN IN 2019 A CENTER OF PERMANENCE FOR REPATRIATION (CPR).

IN CASE YOU LEAVE THE CENTER AND REFUSE TO GO WHERE THEY INTEND TO SEND YOU, YOUR ASYLUM REQUEST WILL BE SUSPENDED FOR 12 MONTHS AND THEN REJECTED:

*COME IMMEDIATELY TO NAGA TO COMMUNICATE THE QUESTURA
AND THE COMMISSION WHERE YOU ARE STAYNG IN ORDER TO GIVE
YOU THE DATE OF THE COMMISSION!*

*NAGA ONLUS, VIA ZAMENHOF 7/A, MILANO (TRAM 15, 3, 90, 91- UNDERGROUND M2 GREEN LINE PORTA GENOVA): YOU WILL FIND DOCTORS AND LAWYERS FREE OF CHARGE FOR YOU!

THE CPR THAY WANT TO OPEN IN VIA CORELLI IS A CLOSED CENTER FROM WHICH YOU CAN NOT EXIT, AND WHERE YOU CAN BE HELD FOR 180 DAYS WHOEVER IS FOUND WITHOUT PERMISSION OF STAY, AFTER A HEARING WITH A JUDGE AND YOUR LAWYER.

AT THE END OF 180 DAYS, YOU MAY BE ACCOMPANIED BY AIRPLANE TO YOUR COUNTRY OF ORIGIN OR YOU CAN RECEIVE AN EXPULSION PAPER WITH AN INTIMATION TO LEAVE ITALY.

THE EXPULSION ORDER CAN BE CONTESTED IN THE COURT WITHIN 30 DAYS.
LOOK FOR A LAWYER! IF YOU DO NOT GET ONE, COME TO NAGA!

MANY OF US REFUSE THE OPENING OF A CPR IN MILAN OR ANY OTHER CITY: WE ALSO FIGHT FOR THE CLOSURE OF ALL OTHER CPRs IN ITALY.



NEWS ABOUT THE "SALVINI" DECREE

(A)

IF YOU HAVE A PERMIT FOR REQUEST FOR ASYLUM:

1) HUMANITARIAN PROTECTION HAS BEEN ELIMINATED, WE DO NOT KNOW HOW MANY WILL BE GRANTED THE NEW FORM OF PROTECTION CALLED "SPECIAL PROTECTION",

IF YOUR APPLICATION IS REJECTED, YOU MAY HAVE AN APPEAL WITHIN 30 DAYS. LOOK FOR A LAWYER! IF YOU DO NOT HAVE ONE, COME TO NAGA!

2) IF YOU LEAVE THE CENTER WITHOUT A JUSTIFICATION, THE EXAM OF YOUR REQUEST IS SUSPENDED UP TO 12 MONTHS. IF DURING THE 12 MONTHS YOU DO NOT COMMUNICATE YOUR NEW ADDRESS TO CONTINUE THE EXAM OF YOUR REQUEST, THIS WILL BE REJECTED

COME IMMEDIATELY TO NAGA TO COMMUNICATE THE QUESTURA AND THE COMMISSION WHERE YOU ARE STAYING AND THE DATE OF THE COMMISSION FOR YOU!

3) IF YOU WANT TO SUBMIT AGAIN A DEMAND, EXACTLY AS THE DEMAND YOU HAVE PREVIOUSLY SUBMITTED, OR IN THE PHASE OF EXPULSION (AND HAVE ALREADY DONE 'ASKED QUESTION BEFORE) OR YOU HAD ALREADY MADE ONE THAT HAS BEEN DECLARED INADMISSIBLE OR REJECTED ...

YOU WILL NOT HAVE THE RIGHT TO STAY IN ITALY AND YOUR APPLICATION MAY BE ASSESSED BY ACCELERATED PROCEDURE

4) IF YOU HAVE APPLIED AND ARE WAITING FOR EXPULSION AND CONSIDER THAT YOUR APPLICATION IS MADE ONLY TO AVOID THE EXPULSION ...

YOU CAN BE TAKEN TO A CPR (I.E. IN MILAN IN VIA CORELLI) AND HELD UP TO 180 DAYS (AFTER A N AUDIENCE BEFORE A JUDGE WITH A LAWYER).

5) IN ORDER TO UNDERSTAND YOUR IDENTITY AND CITIZENSHIP ...

YOU CAN BE HELD IN A HOTSPOT FOR 30 DAYS AND THEN IN A CPR FOR FURTHER 180 DAYS.

IN ALL THESE CASES THE DECISION CAN BE CONTESTED. LOOK FOR A LAWYER! IF YOU DO NOT CE YOU HAVE IT, COME OR GO TO THE NAGA!



6) IF YOU ARE FILED FOR SOME CRIMES (such as violence or threat to a public official, serious or very serious personal injury against a civil servant, robbery or murder, extortion, kidnapping, sexual assault, drug offenses and others): THE COMMISSION DECIDES ABOUT YOUR REQUEST WITHIN 5 DAYS AND IF YOU OBTAIN A REJECTION, YOU MUST LEAVE THE COUNTRY IMMEDIATELY

LOOK FOR A LAWYER! IMMEDIATELY IF YOU DO NOT HAVE ONE, COME TO NAGA!

7) IF YOU ARE SENTENCED OVER CERTAIN CRIMES (such as violence or threat to public officials, serious or very serious personal injury to a civil servant, theft, murder, robbery, extortion, kidnapping, sexual assault, drug offenses and others): YOU CANNOT HAVE THE REFUGEE STATUS IN THE SUBSIDIARY PROTECTION (AND THE REFUGEE STATUS FOR HUMANITARIAN REASONS IS PRACTICALLY NO LONGER GRANTED) THE COMMISSION HAS TO LISTEN TO YOU AND TAKE A DECISION IMMEDIATELY AND IF YOU OBTAIN A REJECT YOU MUST ALSO LEAVE THE COUNTRY EVEN IF YOU TAKE AN ACTION.

LOOK FOR A LAWYER! IMMEDIATELY IF YOU DO NOT HAVE ONE, COME TO THE

8) AT THE END OF THE PROCEDURE FOR THE REQUEST OF ASYLUM:

- IF YOU DO NOT OBTAIN PROTECTION YOU WILL NO LONGER RETURN TO THE CAS, THEREFORE LOOK FOR WHATEVER ACCOMMODATION FOR A TIME! ONLY IF YOU OBTAIN INTERNATIONAL PROTECTION YOU CAN BE ACCEPTED IN A SPRAR.

- IF YOUR REQUEST IS NOT ACCEPTED, YOU CAN REMAIN IN THE CAS ONLY IF YOU ACT AGAINST THE COMMISSION'S NEGATIVE DECISION.

YOU CAN DO AN ACTION WITHIN 30 DAYS, AND STAY IN THE CENTER: LOOK FOR A LAWYER IMMEDIATELY! IF YOU DO NOT HAVE ONE, COME TO NAGA!

9) YOU CANNOT OBTAIN THE REGISTRATION IN THE MUNICIPALITY IN ORDER TO OBTAIN YOUR IDENTITY CARD. AND TO HAVE ACCESS TO THE SERVICES ON THE TERRITORY.

THE PERMIT OF STAY FOR ASYLUM REQUEST IS HOWEVER CONSIDERED AS A VALID IDENTITY DOCUMENT

IF YOU HAVE BEEN RECOGNIZED THE STATUS OF POLITICAL REFUGEE OR SUBSIDIARY PROTECTION:
GOING BACK TO YOUR COUNTRY CAN CREATE SERIOUS PROBLEMS FOR YOUR STATUS AND
PERMISSION!!

ASK NAGA FOR LEGAL ADVICE BEFORE DECIDING!

(C)

IF BEFORE OCTOBER 5th 2018 YOU HAVE ALREADY OBTAINED A HUMANITARIAN PERMIT

AT THE EXPIRATION OF THE PERMISSION, IF THE COMMISSION CONSIDERS YOU ARE ENTITLED, YOU
MAY HAVE A PERMIT OF "SPECIAL PROTECTION" OF 1 YEAR OF DURATION, WHICH WILL NOT BE
CONVERTED INTO WORK PERMIT AND CAN BE RENEWED ONLY IF THE COMMISSION CONSIDERS
THAT ALL THE CONDITIONS ARE MET. IT IS IMPORTANT THEREFORE TO CONVERT THE
HUMANITARIAN PERMIT THAT YOU HAVE INTO A WORK PERMIT (OR OTHER TYPE) BEFORE IT
EXPIRES, OTHERWISE YOU ARE NOT ALLOWED TO RENEW IT ANY MORE!

*IF YOU HAVE ALREADY A WORK OR A WORKING OFFER, COME TO NAGA FOR
INFORMATION ON HOW TO CONVERT YOUR PERMISSION INTO A WORK PERMIT (OR
OTHER TYPE).
IF YOU DO NOT HAVE IT, LOOK FOR A JOB IN ORDER TO CONVERT YOUR PERMIT BEFORE
EXPIRATION!*

(D)

IF ON OCTOBER 5th 2018 THE COMMISSION HAS ALREADY DECIDED THAT YOU ARE ENTITLED
TO A HUMANITARIAN PERMIT, BUT IT HAS NOT BEEN RELEASED YET,

YOU WILL BE GRANTED A PERMIT OF STAY "FOR SPECIAL CASES", FOR THE DURATION OF 2 YEARS,
THAT YOU CAN CONVERT. ONCE THE TWO YEARS EXPIRE, IF THE COMMISSION DOES NOT RECOGNIZE
YOU THE RIGHT, YOU CAN HAVE A "SPECIAL PROTECTION" PERMISSION THAT YOU CANNOT CONVERT.
THEREFORE, BEFORE THE PERMISSION "FOR SPECIAL CASES" EXPIRES, CONVERT IT IMMEDIATELY
INTO A WORK PERMIT (OR OTHER TYPE) OR YOU WON'T BE ALLOWED TO DO IT ANY MORE!

*IF YOU HAVE ALREADY A WORK OR A WORKING OFFER, COME TO NAGA FOR
INFORMATION ON HOW TO CONVERT YOUR PERMISSION INTO A WORK PERMISSION
(OR OTHER TYPE).
IF YOU DO NOT HAVE IT, LOOK FOR A JOB IN ORDER TO CONVERT YOUR PERMISSION
BEFORE THE EXPIRATION!*



(E)

IF YOU HAVE NO PERMIT,

IF YOU ARE FOUND WITHOUT A PERMIT BY THE POLICE FORCES, YOU CAN BE TAKEN TO A CPR (I.E. TO VIA CORELLI IN MILAN), AND WITHHELD UP TO 180 DAYS (AFTER A HEARING BEFORE A JUDGE AND WITH YOUR LAWYER), TO BE IDENTIFIED AND BE EXPULSED TO YOUR COUNTRY, OTHERWISE YOU ARE GIVEN AN EXPULSION PAPER WITH AN ORDER TO LEAVE ITALY.

EXPULSION CAN BE CONTESTED IN THE COURT WITHIN 30 DAYS. LOOK FOR A LAWYER! IF YOU DO NOT HAVE ONE, COME TO NAGA!

(F)

IF YOU OBTAINED ITALIAN CITIZENSHIP:

IT CAN BE REVOKED IF YOU ARE SENTENCED FOR CRIMES SUCH AS TERRORISM, ARMED BAND, SUBMISSION OF GOODS OR MONEY SUBJECT TO SEIZURE OR OTHER SERIOUS CRIMES.

IF YOU HAPPEN TO BE IN THIS CONDITION COME TO NAGA!
