

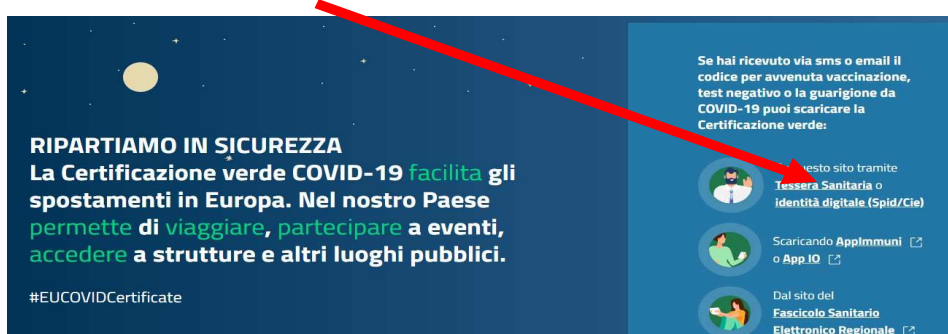


## HOW TO DOWNLOAD THE GREEN PASS IF YOU DO NOT HOLD AN ITALIAN HEALTH CARD AND YOU HAVE BEEN VACCINATED IN ITALY

These instructions are to be followed by those who have been Covid-19 vaccinated (two doses or one, when due) and does not hold a health card (but only has a STP or fiscal alphanumeric code or a 11 digits Unique Code issued by the Prefettura to those who have participated in the 2020 identification procedure) and is interested in being issued a Covid-19 Green Certification. They have been verified in the Lombardia Region only.

### WHAT TO DO?

- Go to the website <https://www.dgc.gov.it/web/>
- Click on “*su questo sito tramite Tessera Sanitaria*” (first item in the box on the right).

- Click on “*utente non iscritto al SSN vaccinato in Italia*” (third point)
- Fill in the required information :
  - o *Codice fiscale o identificativo assegnato da Sistema TS*: you must enter the code already used to make the reservation, i.e.
    - the alpha numeric fiscal code OR
    - the STP code (the one previously held or assigned for the vaccination). Enter the STP code by writing STP before the number OR
    - the 11 digits UNIQUE CODE provided by the Prefettura to those who have participated in the 2020 procedure called “*sanatoria*” = it is the temporary fiscal code exclusively made of numbers to be found in the system for the electronic transmission of the request of “*sanatoria*”, in the section with the worker’s data (website: [nullaostalavoro.dlci.interno.it](http://nullaostalavoro.dlci.interno.it) together with the file code) OR on the receipts of the labor taxes paid
  - o *Data vaccinazione in formato (gg/mm/aaaa)*: enter HERE the date of the second or first dose if one only dose vaccine was required
  - o *Lingua della certificazione*: here the language or languages the certification is required can be selected.

In order to end the procedure it is required that the security code is indicated again and that “*recupera certificazione*” is clicked on.

**IF BY FOLLOWING THE ABOVE PROCEDURE THE GREEN PASS IS STILL NOT DOWNLOADED, A REPORT MIGHT BE SENT TO ATS MILANO.**

At page end there is the sentence “*Hai trovato quello che cercavi?*” you must click on “*No, ho verificato quanto sopra, MA NON ho trovato la soluzione (clicca qui per inserire i dati e chiedere supporto alla ATS)*” and select the proper case from the list visualized (I have been vaccinated with 2 doses; I have been one dose vaccinated, one year after recovery; I have been injected one dose of vaccine and I after that I got Covid sick; I have recovered less that 6 months ago; I have taken a negative swab in the last 48 hours). Load your data and enclose the required documents (identification and all documentation as vaccinal certification and/or swab reports performed IN ONE SINGLE FILE) and send the information by clicking on “*invia*”.

When the certification will be available, a text message or a mail will be received: the message contains an identification code (AUTHCODE) to be used on the channels which require it and short instructions for the retrieval of the certification.
