

REGISTERING FOREIGN MINORS WITH THE HEALTHCARE SERVICE OF REGIONE LOMBARDIA

WHO CAN REGISTER?

All foreign minors under 18 years of age, whose parents are foreign (non-EU) citizens without residence permit or EU citizens without health coverage (i.e. TEAM card), or unaccompanied minors, can register with the Healthcare Service (SERVIZIO SANITARIO) of the Lombardia Region.

WHAT DOES IT MEAN?

This means that all the minors in such situations can get free health care and go to a pediatrician (minors under 14) or to a family doctor (minors 14-18 years old)! Starting from January 2023 **a pediatrician of choice or a family doctor, and the social security number (CODICE FISCALE)** will be assigned to all EU minors, to minors whose parents are foreign citizens without residence permit, to unaccompanied minors (in accordance with Circolare del Ministero della Salute Prot. n.0016282-08/08/2022-DGPROGS-MDS-P; Risoluzione n. 25/E 2022 dell'Agenzia delle Entrate; Deliberazione N° XI / 7758 del 28/12/2022 Regione Lombardia).

The registration will have annual validity and will have tobe renewed every year until the 18th birthday.

WHAT DO YOU NEED TO DO?

- 1. Go to an UFFICIO DI SCELTA E REVOCA of the ATS/ASST office in your city. - 2. Apply to register of your son or daughter with the Healthcare System (SERVIZIO SANITARIO REGIONALE) of Regione Lombardia. The ATS/ASST will request Agenzia delle Entrate to issue the social security number (CODICE FISCALE).
- 3. Get the document that certifies the registration at SERVIZIO SANITARIO REGIONALE and the indication of the pediatrician or the family doctor assigned/of choice.

Exemption (REGIONE LOMBARDIA):

- Exemption from the contribution to pharmaceutical expenditures and for specialist examinations is provided for all minors under 14 years of age, regardless of their family income: medical examinations and medicines are free for all minors under 14 (exemption code, CODICE DI ESENZIONE: E11).
- Exemption is provided for services of Child Neuropsychiatry provided by UONPIA or by accredited private facilities, for minors 14 to 18 years of age registered with the SSR (Regional Health Service), with neuropsychiatric or neurodevelopmental disorders (exemption code: NPI)
